The board discussed funding and grant options for the next phase of comprehensive planning. Municipal Vulnerability Preparedness (MVP), Community One Stop, Planning Assistance Grants (via Executive Office of Energy and Environmental Affairs, 25% match requirement).

On the topic of childcare, Abu-Jaber heard from a high school student who may be able to provide childcare support. Meeting attendee Darlene Stone-Adair volunteered to support.

A senior listening session is planned for Monday 2/26 midday (after lunch) at COA Meal Site.

New planning board member search. Chair Smith shared a one page draft document outlining the roles and responsibilities of board members. Board members felt the document was very well done, and provided a point or two of minor feedback.
