Chairman Robert Barker called the meeting to order at 7:03PM.

- 1. Dillon Sussman of the PVPC gave a high-level overview of draft changes to the Zoning Bylaw. The document title was *Draft Zoning Revisions to Implement the Goals of the 2011 Village Centers Study, The Williamsburg Healthy Aging and Community Design Report (2016), and Smart Growth America's Planning for Economic and Fiscal Health Report and Suggested Next Steps (2016).* Changes were aimed at encouraging development of housing in village centers and encouraging pedestrian-friendly, compact development.
 - Topics included a revision to the Village Mixed zone area, accessory apartments, and new Special Permit and Site Plan Review requirements.
 - Board members were instructed to read the proposed changes in detail for further discussion at the next meeting.
- 2. Chris Flory recapped the responses to letter about signs which the Board had sent to businesses in town. There were no direct responses. Sussman mentioned a recent market study that had been done for the town in which some businesses cited the sign bylaw as a problem. Members of the Board were unaware of the study but would research it.
 - Barker said he had a meeting planned for November 7 with Town Administrator Charlene Nardi and Building Inspector Louis Hasbrouck to discuss enforcement issues.
- 3. Barker passed out copies of the existing zoning bylaw on medicinal marijuana facilities and requested that Board members review it in preparation for work on a bylaw revision to include recreational marijuana.
