- Some projects call for a Site Plan Review as a part of the Special Permit application process.
- The Planning Board does the Site Plan Review and provides a finding and recommendation to the Z. B.A.

SITE PLAN REVIEW CRITERIA

The design should:

- Reasonably protect visual and environmental qualities and property values of the Town.
- Assure safe vehicular access
- Assure safe pedestrian movement
- Provide for adequate drainage of surface water.

THINGS WE ARE NOT HERE TO ADDRESS

- The interior design of the building
- Particulars of design of the exterior of the building, except in the context of fitting in overall to the nearby existing uses
- The suitability of particular design elements for any particular use. For example,
 "Will the 2023 Model XB-9 fire truck fit in the driveway?"

Chair Smith noted the Planning Board may discuss a finding on the Public Safety Complex site plan review at its next meeting, scheduled for Monday January 10th

Rob Todisco, owners project manager at P3, spoke next to present the background and plan. Rob covered the site and building's design goals and intent, a floor plan, and visual renderings.

A question was asked about whether the site is in a historic district. The consensus response was that there was no historical designation present which would impact the plans.

Jeff Squires (Berkshire Design) presented plans and presentation of further information about the site and building

A question was asked about driveway width and the potential problem of disabled vehicles. A short discussion concluded with the perspective that this would not be a concern.

A question was asked about the setback of plantings from the road, with the response that this is planned to be the same as it is now.

A question was asked about the status of Conservation Commission dialogue; respondents noted the next meeting is scheduled for the coming Thursday.

A question was asked about an existing tree, which overlaps a drainage basin on the plan; respondents noted this tree is expected to be removed during construction.

The joint meeting was adjourned.
