In the name of the Commonwealth of Massachusetts, you are hereby directed to notify and warn the inhabitants of said town, qualified to vote in elections and in town affairs, to meet at the **Anne T. Dunphy School, 1 Petticoat Hill Road**, in said town on Tuesday, the thirty-first of August, Two Thousand Twenty-One, at seven o'clock in the evening, then and there, to act on the following articles:

- Article 1
- To see if the Town will vote to raise and appropriate and/or transfer from the Water Enterprise Fund the sum of \$1,927 (one thousand nine hundred twenty-seven dollars) to pay Howard Laboratories, Inc. for services for the Water Department in Fiscal Year 2021 (FY21) or take any other action relative thereto.

(nine-tenths vote required)

- Article 2
- To see if the Town will vote to raise and appropriate and/or transfer from the Sewer Enterprise Fund the sum of \$34,779 (thirty-four thousand seven hundred seventy-nine dollars) to pay the balance of the Fiscal Year 2021 (FY21) Sewer Service cost assessment to the City of Northampton or take any other action relative thereto.

(majority vote required)

(two-thirds vote required)

- Article 3
- To see if the Town will vote to transfer the sum of \$217,872 (two hundred seventeen thousand eight hundred seventy-two dollars) from the Stabilization account for costs associated with the Depot Road Culvert construction, or take any other action relative thereto.

Article 4 To see if the Town will vote to transfer the sum of \$81,292 (eighty-one thousand two hundred ninety-two dollars) from the Stabilization account for costs associated with the Anne T. Dunphy School HVAC (Heating Ventilation and Air Conditioning) system, or take any other action relative thereto. (two-thirds vote required)

And you are hereby directed to serve this warrant by posting up attested copies hereof in at least five places in said Town, at least fourteen days before the date thereof, as within directed.

Hereof, fail not, and make due return of this warrant, with your doings thereon, to the Town Clerk, at the time and place of meeting as aforesaid.
