- 1. Invitation to Bid-Board looked over the IVB as put together by (BL). The Board decided to separate the IVB to a two (2) year bid for the prices. Motion made (EC) and seconded (DH) to require new applications to state that a water meter must be installed prior to the connection to the Town Sewer line.
- 8. Board discussed another letter to be sent to the remaining Flat Rate users that have not responded.
- 9. Motion made (EC) and seconded (DH) to sign the commitment for \$212.86 for a frozen meter at Childs Funeral Home. Motion so voted.
